

LOCAL LAW - 2025

A Local Law Amending Village Code Chapter A162 entitled “Schedule of Fees” as follows:

BE IT ENACTED, by the Board of Trustees of the Inc. Village of East Williston as follows:

Section 1. Amending section A162 as follows (with the language added denoted by underlining, and the language removed struck through):

- (A) All fees that are to be collected within the Village, for work conducted, permit applications submitted and any other collected fee shall be set by resolution of the Board of Trustees. A copy of the pending schedule of fees as set by the Board of Trustees shall be maintained by the Village Clerk.

Section 2. Authority.

The Board of Trustees of the Village of East Williston is authorized to adopt this local law pursuant to Article IX of the New York State Constitution, the Municipal Home Rule Law, the relevant provisions of the Village Law of the State of New York, and the general power vested with the Village of East Williston to promote the expedient resolution of planning issues in the Village.

Section 3. Severability.

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section 4. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State.
